### Technical Specifications for PVC Fluted False Ceiling Panels

Material Composition: PVC resin and calcium carbonate (often WPC or high-density PVC composite).

Panel Thickness: Generally available in 10 mm or 12 mm.

Width: Standard width is 1 foot (approx. 300 mm to 305 mm) or 200 mm, featuring multiple flutes (grooves).

Length: Typically, 10 feet (approx. 2900 mm to 3050 mm).

Weight: Approximately 3.8 kg per 10-foot panel (based on 12mm thickness).

Finish: Available in membrane finish, UV coating, and printed designs (including wooden and marble textures).

Features: Waterproof, termite-proof, fire-retardant, and low maintenance.
