

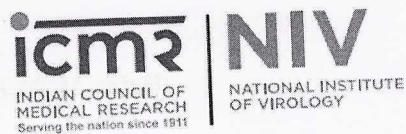

- f) Prices shall be quoted in Indian Rupees only.
