If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. In respect of bid for Services, the bidder must be the Service provider of the offered Service. (i) "I/We hereby declare that I/we have not been Banned/ Suspende d/ Blacklisted or de-listed by any PSU/ Government Department/ Financial Institution / Court." In case, the declaration is found incorrect/false at any later stage, the tender is liable to be rejected, the contract shall be closed without any further notice and Incident will be raise as per GeM Terms and Conditions.

10. The PDF file uploaded should be readable and shall not be password protected.

11. Bidders needs to sign a Bid securing declaration accepting that if they withdraw or modify their Bids during the period of validity, or if they are awarded the contract and they fail to sign the contract, or to submit a performance security before the deadline defined in the request for bids/request for proposals document, they will be suspended for the period of 1 year for bids/request for proposals document from being eligible to submit Bids/Proposals for contracts with ICMR-NIRT.

12. One Bid per Bidder: A firm shall submit only one bid either individually or as a partner of a joint venture. A firm that submits either individually or, as a member of a joint venture, more than one bid will cause all the proposals with the firms' participation to be disqualified.

13. ICMR-NIRT reserves the right to cancel the bid in part or full without assigning any reason and liability on the buyer. On such cancellation the decision of the Director, ICMR-NIRT will be binding and final on the subject.

14. Payment:

(a) No advance payments will be made before executing the contract.

(b) Payment is subject to submission of Performance Bank Guarantee.

- (c) No extra payment will be made on account of transportation handling, loading, unloading, labour charges, etc.,
- (d) The Payment shall be made as per the financial quotes submitted by the bidder and accepted by ICMR-NIRT.
- (e) The payment will be made after satisfactory report from end user concerned.

15. If the supplier fails to deliver any or all of the goods or fails to perform the services within the time frame(s) incorporated in the contract, the purchaser/consignee shall, without prejudice to other rights and remedies available to the purchaser/consignee under the contract, deduct from the contract price, as **liquidity damages, calculated individually on each delayed performance of the contract including delivery, installation, non-submission of documents, etc. a sum equivalent to 0.5% per week of delay or part thereof until actual delivery or performance subject to a maximum of 10% of the contract price.** Once the maximum is reached purchaser may consider termination of the contract. 19. Bidder is requested to give undertaking Certificate regarding land border "I/ We have read the clause issued by Government of India regarding restrictions on procurement from a bidder of a country which shares a land border with India; I/ We certify that the bidder is not from such a country or, if from such a country, have been registered with the Competent Authority"

20. Bidder should comply with all the terms and conditions in the bid document and same must ensure to provide in the letter head.

21. The successful bidder should **complete the work (i.e. according to the scope of work given) in 30 days' time period** after handing over the site for SITC of Neutral Copper Plate Earthing. Hence all the manpower and material should be planned accordingly.
