Special terms and conditions-Version:1 effective from 27-01-2026 for category Biosafety Cabinet (V2)

 - **Comprehensive Warranty**
The comprehensive warranty shall include preventive maintenance, including calibration as per the manufacturer's technical, service, and operational manuals. It shall cover service charges and replacement of spares, except for consumables.
During the warranty period, commencing from the date of successful installation and commissioning, service personnel shall visit each consignee site at least once every six months or as recommended in the manufacturer's manuals. The warranty shall ensure 98% uptime on a 24 hours x 7 days x 365 days basis. In case of downtime beyond the permissible limit, the warranty period shall be extended by double the duration of the downtime.
 - **Service Centres**
The seller shall provide details of authorized service outlets in India at the time of supply, including complete addresses, telephone numbers, and email IDs. It shall be the seller's responsibility to ensure that authorized service centres are available within a reasonable distance from each installation site to handle service calls promptly. Details of toll-free numbers and facilities for online registration of service requests shall also be provided to the buyer/consignee at the time of supply.
 - **Source of Supply**
The seller shall provide documentary evidence to establish the source of the equipment, such as a copy of the proforma invoice or equivalent documents, confirming that the supplied products are manufactured by the indicated OEM and sourced directly from them.
 - **Packing and Marking**
As medical equipment is delicate and sensitive, the packing shall be strong and durable enough to withstand transit (including transshipment, if any), rough handling, and open storage without damage or deterioration. The packaging design shall consider the size, weight, and volume of the equipment, the remoteness of the final destination, and the availability of transport and handling facilities en route.
Each package shall be clearly marked on three sides with indelible paint of proper quality, indicating the contract number and date, a brief description of goods and quantity, packing list reference number, country of origin, and any other relevant details. Accessories shall be suitably labeled and packed.
 - **Spare Parts**
The seller shall provide all relevant information and materials pertaining to spare parts manufactured and supplied by the OEM. It shall be ensured that required spares remain available for purchase for at least 10 years from the date of supply. In the event of discontinuation of any spare part, the seller shall give sufficient advance notice to the buyer/consignee to enable advance procurement.
The OEM and its authorized service centres/dealers shall maintain adequate inventories to ensure ex-stock availability of consumables and spares. Further, the OEM or reseller shall accord the buyer/consignee "most favoured client" status and offer the most competitive prices for all spares and consumables related to the supplied equipment.
 - **Installation, Training, and Manuals**
The seller shall be responsible for installation, commissioning, supervision, and demonstration of the equipment. Required jigs, tools, and minor civil works needed for installation shall be provided by the seller. Training shall be imparted to the consignee's representatives for proper operation and maintenance of the equipment. The seller shall supply the required number of operation and maintenance manuals.
If the product category parameters specify any additional requirements for installation, training, or documentation, those shall also apply.
 - **Electrical Safety Checking**
The seller shall furnish a list of equipment and instruments required for performing routine and

preventive maintenance to the buyer/consignee. Periodic electrical safety checks shall be performed as per relevant BIS safety standards or equivalent. If the seller does not possess the required testing facilities, safety compliance shall be verified through accredited laboratories during each preventive maintenance visit.

- **Software**

All software updates shall be provided free of cost during the warranty period.

2. Bidders needs to sign a Bid securing declaration accepting that if they withdraw or modify their Bids during the period of validity, or if they are awarded the contract and they fail to sign the contract, or to submit a performance security before the deadline defined in the request for bids/request for proposals document they will be suspended for the period of 1 year for bids/request for proposals document from being eligible to submit Bids/Proposals for contracts with ICMR.

3. Eligibility: The Bidder must be a Manufacturer or its authorized Agent.

4. One Bid per Bidder: A firm shall submit only one bid either individually or as a partner of a joint venture. A firm that submits either individually or, as a member of a joint venture, more than one bid will cause all the proposals with the firms' participation to be disqualified.

The packing shall be sufficient to withstand, without limitation, rough handling during transit and exposure to extreme temperatures, salt, and precipitation during transit and open storage. Packing case size and weights shall take into consideration, where appropriate, the remoteness of the Goods, final destination and the absence of heavy handling facilities at all points in transit

b) The packing, marking, and documentation within and outside the packages shall comply strictly with such special requirements as shall be expressly provided for in the Contract. i

ncluding additional requirements strictly as per Technical Specifications, and in any subsequent instructions ordered by the Procurement agency.

(c) Packing and Marking shall be strictly as per Technical Specifications and will be inspected in terms of provisions of specifications before clearing for dispatch.

8. Payment: 100% payment shall be made after receipt of complete goods/Equipment in good condition, acceptance and successful installation of goods/Equipment and subject to submission of Performance Bank Guarantee. This payment is subject to recoveries, if any, either on account of statutory deduction/ taxes/ Liquidated Damages, if any and non-rectification of defects/ deficiencies not attended by the Supplier or otherwise. The firm is required to submit the following documents :

(a) Copy of Purchase Order;

(b) Copy of Extension Order (if any);

(c) Invoice in original showing contract number, goods description, quantity, unit price and total amount

(d) Installation Report in original duly signed and sealed by the authorized officer of the consignee;

(e) Acknowledgement of Receipt of Goods issued by the consignee Institute/ Center

(f) Performance Bank Guarantee

9. Settlement of Disputes:- (a) If any dispute or difference of any kind whatsoever shall arise between the Procurement agency and the Supplier in connection with or arising out of the Contract, the parties shall make every effort to resolve amicably such dispute or difference by mutual consultation.

(b) If, after thirty (30) days, the parties have failed to resolve their dispute or difference by mutual consultation,

then either the Procurement agency or the Supplier may give notice to the other party of its intention to commence arbitration, as hereinafter provided, as to the matter in dispute, and no arbitration in respect of this matter may be commenced unless such notice is given.

(c) Any dispute or difference in respect of which a notice of intention to commence arbitration has been given in accordance with this Clause shall be finally settled by arbitration. Arbitration may be commenced prior to or after delivery of the Goods under the Contract. In the case of a dispute or difference arising between the Purchaser/Consignee and a domestic Supplier relating to any matter arising out of or connected with the contract, such dispute or difference shall be referred to the sole arbitrator appointed by Director General ICMR.

(d) Arbitration proceedings shall be conducted in accordance with the rules of procedure which are as follows

(i) The venue of Arbitration shall be the place from where the contract is issued and the language of the arbitration proceedings and that of all councils and communications between the parties shall be English. (ii) The decision of the majority of arbitrators shall be final and binding upon parties.

(iii) Settlement of disputes through pre-institution mediation and settlement in accordance with the commercial courts, commercial division and commercial appellate division of High Courts (Amendment) Act 2018 No. 28 of 2018 Chapter IIIA.

(e) Settlement of Disputes: Notwithstanding any reference to arbitration herein, the parties shall continue to perform their respective obligations under the Contract unless they otherwise agree; and The Procurement agency shall pay the Supplier any monies due to the Supplier.

10. Consignee details (Place of Delivery, Installation, Commissioning) - ICMR - NIV, Pune.

11. Unless otherwise instructed, the supplier shall make arrangements for insuring the goods against loss or damage incidental to manufacture or acquisition, transportation, storage and delivery in the following manner:

a) In case of supply of goods on Consignee site basis, the supplier shall be responsible till the entire store contracted for arrival in good condition at destination. The transit risk in this respect shall be covered by the Supplier by getting the stores duly insured. The insurance cover shall be obtained by the Supplier and should be valid till 3 months after the receipt of goods by the Consignee.

(b) If the Equipment is not commissioned and handed over to the consignee within 3 months, the insurance will be got extended by the supplier at their cost till the successful installation, testing, commissioning and handing over of the goods to the consignee. In case the delay in the installation and commissioning is due to handing over of the site to the supplier by the consignee, such extensions of the insurance will still be done by the supplier, but the insurance extension charges at actual will be reimbursed.

(c) Insurance would be borne by the Supplier. Insurance Certificate for 110% of the value to be insured in favour of Indian Council of Medical Research, covering all risks basis for the goods from supplier/ manufacturer warehouse to consignee warehouse

12. If the supplier fails to deliver any or all of the goods or fails to perform the services within the time frame(s) incorporated in the contract, the purchaser/consignee shall, without prejudice to other rights and remedies available to the purchaser/consignee under the contract, deduct from the contract price, as liquidity damages, calculated individually on each delayed performance of the contract including delivery, installation, non-submission of documents, etc. a sum equivalent to 0.5% per week of delay or part thereof until actual delivery or performance subject to a maximum of 10% of the contract price. Once the maximum is reached purchaser may consider termination of the contract. Since the Liquidated damages are in virtue of non-performance of services, it will attract GST or any other applicable taxes which in turn shall be deducted from the Supplier

13. GST will be applicable as per the latest Govt notification.

14. Delivery of Equipment means Supply, Installation, Testing and Commissioning of Equipment.

15. Following Categories Sellers are exempted from Years of Experience and Turnover.

(a) Micro and Small Enterprises who are manufacturer of the Primary Product Category and give specific confirmation to this effect at the time of bid submission and whose credentials are validated online through Udyam Registration/ Udyog Aadhaar (as validated by Government from time to time) and through uploaded supporting documents.

(b) Start-ups as recognized by Department of Industrial Policy and Promotion (DIPP).

16. The manufacturer's authorization must be insisted upon on a tender specific basis, not general authorization/dealership, by so declaring in the bid documents clearly. In cases where the manufacturer has submitted the bid, the bids of its authorized dealer will not be considered. In cases of agents quoting in offshore procurements, on behalf of their principal manufacturers, one agent can not represent two manufacturers or quote on their behalf in a particular tender enquiry. One manufacturer can also authorize only one agent/dealer.

17. Bidder is requested to give undertaking Certificate regarding land border "I/ We have read the clause is sued by Government of India regarding restrictions on procurement from a bidder of a country which shares a land border with India; I/We certify that the bidder is not from such a country or, if from such a country, have been registered with Competent Authority.
