Availability of Office: Office should be in the state of consignee i.e. Tamil Nadu. Only GST Certificate and MSME Registration Certificate with local office address should be submitted as proof.

Payment:

- (a) No advance payments will be made before executing the contract.
- (b) Payment is subject to submission of Performance Bank Guarantee.
- (c) No extra payment will be made on account of transportation handling, loading, unloading, labour charges, etc.,
- (d) The Payment shall be made as per the financial quotes submitted by the bidder and accepted by ICMR-NIRT.
- (e) The payment will be made after satisfactory report from end user concerned.

Liquidated Damages: If the supplier fails to deliver any or all of the goods or fails to perform the services within the time frame(s) incorporated in the contract, the purchaser/consignee shall, without prejudice to other rights and remedies available to the purchaser/consignee under the contract, deduct from the contract price, as liquidated damages, calculated individually on each delayed performance of the contract including delivery, installation, non-submission of documents, etc. a sum equivalent to 0.5% per week of delay or part thereof until actual delivery or performance subject to a maximum of 10% of the contract price. Once the maximum is reached purchaser may consider termination of the contract. Since the Liquidated damages are in virtue of nonperformance of services, it will attract GST or any other applicable taxes which in turn shall be deducted from the Supplier.

The successful bidder should complete the work (i.e. according to the scope of work given) **in 30 days'** time period after handing over the site for the proposed works. Hence all the manpower and material should be planned accordingly.

For all provisions of the Labour Codes that are pending operationalisation through rules, schemes or notifications, the corresponding provisions of the pre-existing labour enactments (such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972, etc. and relevant State Rules) shall continue to remain applicable.

The Seller/ Service Providers shall, therefore, be responsible for ensuring compliance under:

- **All notified and enforceable provisions of the new Labour Codes as mentioned hereinabove; and**
- **All operative provisions of the erstwhile Labour Laws until their complete substitution.**

All obligations relating to wages, social security, safety, working conditions, industrial relations etc. and any other statutory requirements shall be strictly met by the Seller/ Service Provider. Any non-compliance shall constitute a breach of the contract and shall entitle the Buyer to take appropriate action in accordance with the contract and applicable law.

This Bid is governed by the General Terms and Conditions, conditions stipulated in Bid and Service Level Agreement specific to the Service, as the case may be, as provided in the Marketplace.

However, in case of Service, if any condition specified in General Terms and Conditions is contradicted by the conditions stipulated in Service Level Agreement specific to said Service, then it will over-ride the conditions in the General Terms and Conditions.
