On behalf of the DG, ICMR, applications are now invited against vacancies for ICMR Emeritus Scientist positions in the field of biomedical research from eligible (may please see minimum eligibility in the existing guidelines) senior retired medical scientists/researchers/medical teachers who have superannuated or due to retire within three months from the date of advertisement from leading UGC recognized research institutes/organizations/NMC recognized medical colleges/other R&D institution/Institute of National importance in India who may belong to Medical/Biomedical/Life Sciences field with an excellent track record in the concerned area of health research expertise and want to continue the ongoing research work in order to bring it to a logical conclusion.

Procedure for applying:

1. The area of contribution should be matched with the priority areas of ICMR and National Health priorities.
2. Applications to be duly forwarded by the Head of the host institute/organization.
3. The work proposal to be undertaken as an ICMR Emeritus Scientist to achieve the stated objectives should be given in detailed format.
