## GUIDANCE ON RAPID ANTIBODY TEST KITS FOR COVID-19

### **RAPID ANTIBODY tests are not recommended for diagnosis of COVID-19 infection**

- Can be done on blood/serum/plasma samples
- Test result is available within 30 minutes
- Test may come positive after 7-10 days of infection
- The test may remain positive for several weeks after infection
- Positive test indicates exposure to SARS-CoV-2
- Negative test does not rule out COVID-19 infection

### **Please Note:**

- These rapid antibody test kits have been validated in the laboratory. However, the performance of the kits may be subject to variation under field conditions.
- Above listed kits are validated with the mentioned batch number only. Responsibility for batch to batch consistency lies with the manufacturer.
- Antibody based rapid tests which are US-FDA approved can be used directly after due marketing approval from DCGI.

# The marketing licenses to the distributors of companies at s.no. 13 & 14 have been **cancelled** by the Central Drugs Standard Control Organization (CDSCO).

## Rapid Antibody kit of Biomedomics COVID-19 IgM IgG Rapid Test manufactured by BioMedomics (CE-IVD), China and Standard Q Covid -19 IgM/IgG Duo test manufactured by M/s S.D. Biosensor, Inc South Korea of the specified batches were evaluated by ICMR earlier. However, the marketing licenses of the distributors of the above two companies have been **suspended** by the Central Drugs Standard Control Organization (CDSCO) after removal of the COVID-19 serology test kits from the notification list by USFDA.
